AUDIT EXECUTIVE SUMMARY:

The ranch La Cabaña has 30 ha dedicated to conventional production of broccoli, celery, iceberg, romaine, green and red lettuces. Brussels sprouts and cabbage were requested in the scope; however, these crops had not been cultivated in the last 12 months and were not included in this audit scope as confirmed in the opening meeting. There is a drip fertigation system connected directly to their own well located in the property. The water used for foliar applications, cleaning activities and hands washing is provided by this water source. The production season is all the year and the destination markets are Mexico, Canada, and USA. During the audit were interviewed 5 employees dedicated to irrigation and general labours in the crops who demonstrate knowledge about the food safety rules and basic trainings showed during the documental evaluation. The ranch is adjacent to the north and south with agricultural fields with corn, in the east with greenhouses and in the west with natural vegetation and a property protected with a 2 meter high stone wall. During the inspection were observed the lettuces, cauliflower and celery. The products not observed but with similar risk were broccoli and cauliflower.
